## Exemptions

A person who is a council member on the day on which the Local Government Regulations Amendment (Induction and Training) Regulations 2019 regulation 8 comes into operation is exempt from the requirement in section 5.126(1) until the end of their term of office [Regs s.36(2)]

Council Members can access training and development programs as per Council Policy 4.1 Council Member Continuing Professional Development & Travel.

<sup>(1)</sup> A local government must prepare a report for each financial year on the training completed by council members in the financial year.

<sup>(2)</sup> The CEO must publish the report on the local government's official website within 1 month after the end of the financial year to which the report relates. [Section 5.127 inserted: No. 16 of 2019 s. 61.]

<sup>\*\*</sup>Council Members are exempt from 'Council Member Essentials' if they have completed the Diploma in Local Government. [Regs s.36.(1)(i), but can attend refresher courses.
