The former Globe Brewery was predominantly a series of large, corrugated iron clad industrial buildings with a small, painted, rendered brick shopfront office located on the street boundary. The office is the only remaining original building on the site following the demolition of the old brewery proper and subsequent redevelopment of the land for residential purposes. The office is of a Federation Free Style character, with a rendered parapet carrying the brewery's name and the 'Globe' logo in a central pediment over the entry doors. The parapet conceals the hipped, corrugated zincalume roof behind. Currently a bull-nosed awning overhangs the street and protects the front of the building; however, this may be a replacement for an earlier verandah supported on posts. Two large windows, with unusual mullion configuration, are located either side of the central entry doors.

HISTORY

In 1908 a new brewery was opened in Evans Street (now Cunningham Street) by Messrs. C.F. Speed and W. Hetherington of Perth. The land, consisting of Lots 95, 96 and 113, was purchased from Ed. Shenton, and

included a warehouse on Lot 96. Lot 113 was vacant and was used to graze the Clydesdale horses used for deliveries. The new brewery building, constructed by Quain Bros. of Perth, was regarded as having the most up-to-date machinery south of the equator. Sister Bain describes the brewery building as being "so large that it eclipsed every other structure in the town with its square tower rising sixty feet above the ground, making it a notable landmark for miles around." Meanwhile, the stone cellars measured 30 feet by 60 feet. At first water was obtained from three wells on the lots but later it was purchased from the railways, from the condenser. (Bain, M.A., "A Life of its Own", City of Geraldton, 1996, p130) In 1915 Mr. Jas Elliot was appointed as manager and remained in that position for several years. Not long after the brewery was sold to a new group called The Globe and its directors were Messrs O. Green, J. McKay, F.H. Hanson and M. Quain, licensees of the Victoria, Railway, Freemasons and Commonwealth Hotels respectively. Over the years three well known brewers worked at The Globe Brewery - Dick Elliot, Breheny and Paddy Cunningham. (Ibid., p130-131) A local resident recalls that the Globe Brewery consigned cargo to Carnarvon, Roebourne, Port Hedland, Broome, Derby and stations in the Murchison District. (W.J. Cunningham, 26 Cunningham Street, Geraldton, ph: 21 2373) The Globe was beset by a number of problems over the years, including high Excise Duty, an acute bottle shortage in 1946, and failed attempts to obtain part of the Singapore market owing to ships refusing to stop at Geraldton. By 1949 much of the brewery's machinery had become inadequate and ineffective. Faced with considerable expenditure for replacement machinery the company announced in May that it would close. In that same year Tropical Traders opened a crayfish processing and canning factory in the Globe Brewery building. (Op Cit., Bain, M.A., p209) In 1962 the Swan Brewery not only bought the old brewery but also the seven hotels which The Globe had purchased over the years. (Ibid., p131) Thought to be the tallest structure in Geraldton in its day, the white timber tower of the brewery complex, was damaged during a storm and demolished in September, 1963. Described as "one of Geraldton's best known landmarks", the jarrah tower was used by crayfishermen as a landmark on which to sight while laying their pots at sea off port. ("The West Australian", 29/8/1963)

In more recent years the former brewery buildings were used by Planet Fisheries and the Fremantle Fisherman's Co-op as a processing factory, prior to being demolished, leaving only the office building. When the land was redeveloped for residential purposes the old office building was restored for use as a unit.

The former Globe Brewery Office Building has high social and historical significance for Geraldton for its association with the local brewing industry which was a major source of local employment for nearly a century. The Office building is the last remnant of the large complex of industrial buildings which housed on this site. The place has aesthetic value for its high integrity and decorative detailing and makes an important contribution to the local built environment.
