

Geraldton CHRMAP Summary of Community Engagement

Geraldton Coastal Hazard Risk Management and Adaptation Planning Report Expanded Community/Councillor Consultation Paper

There has been extensive community engagement with the community and other stakeholders throughout the CHRMAP process.

Community Engagement around coastal adaptation planning began in 2016 with the completion of two of the three Coastal Erosion and Inundation Reports and the presentation of the Coastal Adaptation Planning Forum by the City, NACC and the Mid-West Ports Authority. The forum informed the community on the CHRMAP process and how residents could be involved. The following is a timeline of the community engagement process leading to the development of the Draft CHRMAP document.

CHRMAP Project Steering Group

A steering group was established in October 2016 to guide the Geraldton CHRMAP project – including two community representatives. The group has been involved through all stages of the project from development of the CHRMAP brief through to providing feedback on the final draft Geraldton CHRMAP report.

CHRMAP Development Community Engagement Overview

The City and the Project consultant team developed and implemented a community and stakeholder engagement strategy in accordance with SPP2.6 requirements. This included a Coastal Planning Community Survey followed by two Coastal Planning Workshops.

The Coastal Planning Community Survey Report is included in the Draft Geraldton CHRMAP Report Project (Part 1: Coastal Hazard and Risk Assessment Report Technical Appendix A.2 Community Engagement Workshop Summary).

The opportunities to engage with the City in the project were extensively promoted and consultation results shared broadly with the community in alignment with the Community Engagement Policy.

Coastal Planning Community Survey and Coastal Planning Workshops

On 14 October 2017, the City held two coastal planning workshops. **These were attended by 88 members of the community**. City officers and coastal engineering consultants, BAIRD summarised the hazard mapping already completed and provided information on the coastal assets and values potentially at risk now, and into the future.

At the same time (2 October to 23 October 2017) a community coastal survey was undertaken via SurveyMonkey. **The City received 376 responses to the survey.**

The purpose of the survey and workshops was to:

- Identify key coastal infrastructure/assets that hold economic, social and environmental value;
- Describe the risk analysis framework summarised earlier in this report and, in particular the consequence scale for the identified coastal hazards;
- Define risk **tolerances** to the identified coastal hazard risks; and
- Receive feedback on proposed adaptation options that could address the risks, and identify additional adaptation options.


