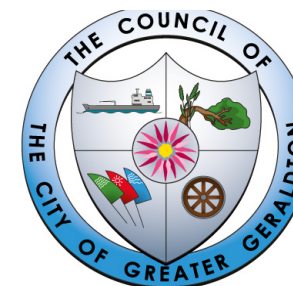

#### \*s.5.127. Report on training

(1) A local government must prepare a report for each financial year on the training **completed** by council members in the financial year.

(2) The CEO must publish the report on the local government's official website within 1 month after the end of the financial year to which the report relates

[Section 5.127 inserted: No. 16 of 2019 s. 61.]

#### Exemptions

*The council member passed the Diploma of Local Government (Elected Member); within the period of 5 years ending immediately before the day on which the council member is elected section 36(1)(a)*

*A person who is a council member on the day on which the Local Government Regulations Amendment (Induction and Training) Regulations 2019 regulation 8 comes into operation is exempt from the requirement in section 5.126(1) until the end of their term of office [Regs s.36(2)]*
