WELCOME TO THE CHAPMAN ESTUARY TIMES

Welcome to the fourth edition of the Chapman Estuary Times Newsletter. This newsletter provides the community with an update on the status of the recommended actions identified in the Chapman River Estuary Reserve Action Plan 2022-25. The newsletter will be uploaded to the City's website every second month.

What's been happening in the Estuary?

A deliberately lit fire swept through the south-western corner of the Chapman Estuary along Crowtherton Street on 8th April. The perpetrator has since been caught by police. Thank you to DFES staff and local bushfire brigade volunteers for attending and promptly extinguishing the bushfire which minimised the damage to the area and surrounding private property.

TAFE students have recently returned to the Estuary to undertake follow-up weed mapping and vegetation surveys. We look forward to seeing their reports.

Two large rabbit warrens were identified on the grassed area north of river mouth. These warrens were fumigated with entrance/exits filled in with sand and hessian.

What's been happening at the Chapman River Regional Park?

A rabbit and kangaroo proof enclosure has been erected in the Park, adjacent to Ego Creek, in preparation for this seasons revegetation program. The area will accommodate up to 6000 native seedlings.

The six week long feral rabbit baiting program across the Park has finished. The City's licenced contractor reported a total control of 4410 rabbits. This is a great result for the environment and surrounding private properties.

We continue to advocate to the community that the responsibility for biosecurity is shared by everyone. The City encourages neighbours to work together to implement rabbit control measures across multiple properties which has greater effectiveness.

Unfortunately, there is no simple solution to this complex rabbit problem. We encourage landowners to commit to ongoing control activities using different management strategies. Check out our website here for more information.

The Rabbit Control workshop held on 23rd February was a great success. The City is investigating a potential collaborated Calicivirus release with private landholders and City managed contractors for the 2025 season. Fence and gate vandalism is an ongoing issue in the Park. The latest vandalism repair has been to a section of the fence line at Tappak St entrance.

DID YOU KNOW?

The Chapman River Estuary contains a subtropical and temperate coastal saltmarsh. This important Threatened Ecological Community provides a breeding and nursery habitat for fish, birds, and crustaceans. Other important values include erosion control, nutrient filtering, and carbon storage.

A major threat to the coastal saltmarsh at the Chapman River Estuary is foot and bike traffic. If visiting the estuary, please stick to paths and trails.

MANAGEMENT ACTIONS UPDATE

E1 Rabbit Control

Recommended Action: Rabbit control.

Action to Date: The 6 week long feral rabbit baiting program across the Park has finished. The City's licenced contractor reported a total number of 4410 rabbits controlled within this timeframe. The treated rabbit number is calculated by total pindone bait laid and consumed over the 6 week period. Any excess bait leftover was removed or neutralised and buried. Two large rabbit warrens were located at the Estuary. One had 9 entrance/exits and the other had 7. These warrens were fumigated with entrance/exits filled in with sand and hessian.

E2 Weed Control

Recommended Action: Weed Control

Action to Date: Upcoming Boxthorn Blitz workshops are currently being organised. Keep an eye out on City socials and the next newsletter for dates and locations.

E5 Monitoring of Threatened Ecological Community

Recommended Action: Continue long-term

monitoring by stakeholders

Action to Date: In March 2024 Environmental Monitoring and Technology students from Central Regional TAFE were back out at the Estuary to conduct weed mapping and vegetation surveys. We look forward to seeing their reports.

CRF continue to be an "eyes on the ground" at the Estuary and promptly report any issues to the City.

E7 Opportunities for revegetation

Recommended Action: Opportunities for revegetation

Action to Date: Organisation of CRF's community planting day is currently underway with the City. This will be held along Swan Drive at the Chapman Estuary. Keep an eye out on City socials and the next newsletter for a date and time. Morning tea will be provided and everyone is welcome so please come along and join in.

S3 Signage – Review signage and install/ remove signage as required

Recommended Action: Develop a signage plan consistent with messaging, education and compliance.

Action to Date: The Environmental team is currently working on a collaborative signage project with Department of Planning, Lands and Heritage and Yamatji Southern Regional Corporation that highlights the Estuary's cultural history and importance to local Aboriginal people. This project is in the initial planning stages.


S5 Install/ Renew Seating

Recommended Action: Install and renew bench seating.

Action to Date: The Environmental team is waiting on a Regulation 10 approval through the revised ACH Act 1972 to replace the recreational seat by Nazareth House.
