MULLEWA GYMNASIUM AGREEMENT

USE OF GYMNASIUM BY SWIPE CARD HOLDERS

- 1. Entry to the Gymnasium by use of a swipe card is only permitted between the hours 6:00am to 8:00pm.
- 2. Only persons 16 years of age or over will be authorised by the office to have access to the Mullewa Gymnasium during the above-mentioned times.
- 3. In the case of a couple who want to use the Gym together it will be permitted for them to have one swipe card between them, but each must pay for individual membership.
- 4. The swipe cardholder shall be responsible for the swipe card and shall not permit other person's access to the Gymnasium and in particular, children under the age of 16 years are not permitted to accompany the swipe cardholder. Swipe cards are not transferable and are not to be lent to any other person.
- 5. If the Gymnasium is not to the required standard, use of the Gymnasium will not be permitted. Swipe cardholders shall comply with any notice at the entrance to the Gymnasium or to any direction given by Council staff that the Gymnasium is not to be used. Notwithstanding this, should the office be unaware of any issues at the Gymnasium, if a notice is not displayed advising of any issues the swipe cardholder can use the Gymnasium at their own risk.
- 6. If any Gymnasium equipment is out of order and there is a sign displayed on that piece of equipment, the cardholder must not use that piece of equipment. Users who identify equipment as faulty are to report it to the Mullewa District Office.
- 7. Once you have completed your Gym session, please make sure that all weighs are put away and the Gymnasium is left clean and tidy.
- 8. The door to the Gymnasium shall remain locked at all times. Users of the Gymnasium are to ensure that the door is locked immediately after entering the facility and on leaving.
- 9. The swipe cardholders are permitted only to the entry and use of the Gymnasium facilities. All other areas are strictly out of bounds.
- 10. Failure to comply with any of these conditions will result in the cancellation of this agreement.
