Extraordinary Election

I refer to an email dated 13 December 2021 from Ms Katrina Wheeler advising that a vacancy now exists in the City of Greater Geraldton after the resignation of a Councillor and the City requesting a cost estimate to conduct an extraordinary election as a postal election.

The estimated cost to conduct the extraordinary election would be \$70,000 including GST which has been based on the following assumptions:

- 27,600 electors;
- Use of Australia Post's regular mail service;
- response rate of approximately 30%;
- appointment of a local Returning Officer; and
- count to be conducted in Geraldton.

The additional cost of using the Australia Post Priority Service for the delivery of the election packages is approx. \$6,500.00 including GST.

Costs not incorporated in this estimate include:

- any legal expenses other than those that are determined to be borne by the Western Australian Electoral Commission in a Court of Disputed Returns and.
- one local government staff member to work in the polling place on election day.





The Commission is required by the *Local Government Act 1995* to conduct local government elections on a full cost recovery basis. Please note that this is an estimate only and may vary depending on a range of factors including the cost of materials or number of replies received. The basis for our charges is all materials at cost and a margin on staff time only.

The current procedure required by the Act is that my written agreement has to be obtained before the vote by Council is taken. To facilitate the process, you can take this letter as my agreement to be responsible for the conduct of the local government extraordinary election for the City of Greater Geraldton in accordance with section 4.20(4) of the *Local Government Act 1995*. My agreement is subject to the proviso that the City of Greater Geraldton also wishes to have the election undertaken by the Western Australian Electoral Commission as a postal election.

Section 4.9(1) of the *Local Government Act 1995* requires that an election date now needs to be decided and set by either the Mayor in writing or by the Council at a meeting within one month of the vacancy occurring. I have enclosed an election schedule for a suggested election date of Friday 25 March 2022. Can you please advise the Commission of the election date when the date has been set.


