<p>POLICY STATEMENT</p> <p>The Council of the City of Greater Geraldton may establish formal or informal relationships with the Governments of Cities in other Nations for the purposes or economic, social, cultural or environmental development in the mutual interests of the Cities.</p> <p>For the purposes of this policy - Sister City Relationships and Strategic Partnerships are defined as:</p> <ul style="list-style-type: none"> • Sister City Relationships are formal agreements between City governments with economic, social and cultural dimensions. • Sister City relationships are much broader in scope than a Strategic Partnership, with emphasis on developing and nurturing long-term relationships on behalf of, and involving, their respective businesses and communities. • Strategic Partnerships are formal relationships between cities that are typically less broad in scope than a Sister City relationship. - In addition to formal Sister Cities, the City may also establish Strategic Partnerships as determined by Council;
- Proposals that conform to the selection criteria will be submitted for endorsement by Executive Management Team followed by a Council decision.

3. Selection Criteria

The following criteria should be utilised in the selection of Sister City or Strategic Partner City.

General Criteria:

- Gross Domestic Product: should be comparable to the Mid West region or larger or of an equivalent proportional GDP ratio of country to region;
- Growth: Candidate Cities should have favourable growth rates;
- Economic Activity: Candidate Cities should have strong trade activity;
- Potential: Candidate Cities should be identified as priorities for future development;
- Investment: Candidate Cities should have potential for mutual investment;
- Commercialisation: Candidate Cities should have potential for cooperation in commercially applicable research;
- Academic organisations: Candidate Cities should have academic institutions such as colleges, universities and research centres;
- Innovation: Candidate Cities should encourage new technologies, research and invention;
- A new Relationship needs to be based on agreed projects / programs for which Council has endorsed a resource allocation.

Economic Development:

- Support the City of Greater Geraldton's strategic priorities
- Expand the City's network of business contacts and relationships
- Increase international private sector investment in the Mid West
- Provide a conduit between local innovation and international industry
- Accelerate economic growth through commercial partnerships
- Leverage existing industry strengths into increased innovation and job creation
- Grow the Traded Sectors of the City's regional economy
- Promote the Mid West region as an attractive tourist destination

2. Principles of Establishing International Relationships

The following principles should apply to International relationships:

- The City of Greater Geraldton may have one Sister City per country and a maximum of 6 Sister City relationships at any one time;
- The City of Greater Geraldton may only add one Sister City per year;
- The proposed Candidate City must be with a country with which the Federal Government of Australia and/ or Government of Western Australia has a positive relationship;
- In addition to formal Sister Cities, the City may also establish Strategic Partnerships as determined by Council;
- Proposals that conform to the selection criteria will be submitted for endorsement by the Executive Management Team followed by a Council decision.

3. Selection Criteria

The following criteria should be utilised in the selection of Sister City or Strategic Partner City.

General Criteria:

- Gross Domestic Product: should be comparable to the Midwest region or larger or of an equivalent proportional GDP ratio of country to region;
- Growth: Candidate Cities should have favourable growth rates;
- Economic Activity: Candidate Cities should have strong trade activity;
- Potential: Candidate Cities should be identified as priorities for future development;
- Investment: Candidate Cities should have potential for mutual investment;
- Commercialisation: Candidate Cities should have potential for cooperation in commercially applicable research;
- Academic organisations: Candidate Cities should have academic institutions such as colleges, universities and research centres;
- Innovation: Candidate Cities should encourage new technologies, research and invention;
- A new relationship needs to be based on agreed projects/ programs for which Council has endorsed a resource allocation.

Process to Establish a New International Relationship</p> <p>All international relationship proposals should be analysed based on the goals and objectives and must be submitted to the Executive Management Team for endorsement and then to Council for deliberation.</p> <p>5. Management of International Relationships</p> <p>After a new relationship has been approved by Council, all activities associated with programs (such as visits overseas, hosting visits and coordinating local groups seeking to engage with Sister Cities or Strategic Partner Cities) should be coordinated by the Economic Development Officer responsible for foreign affairs, in consultation as necessary with the Mayor and CEO, to ensure that all activities meet the objectives of this policy.</p> <p>6. Relationship Plan</p> <p>Every International relationship under consideration should have a relationship plan outlining:</p> <ul style="list-style-type: none"> • The key objectives of the relationship. For example, encouraging and facilitating economic, social-cultural and environmental exchanges, developing networks; • Long-term goals; • Key focus areas for the relationship; • The main stakeholders; • Key performance indicators to measure benefits/outcomes. <p>7. Budget and Resource Commitment</p> <p>Currently, the City of Greater Geraldton has an on-going and budgeted operational level of funding in order to support existing Sister City or Strategic Partner relationships. This recurrent allocation is reflected in the City's Long Term Financial Plan (LTFP) and aligned with actions set out in the City's Corporate Business Plan. Each year the level of funding is reviewed through the annual budget process and review of the LTFP.</p> <p>Where an existing or proposed new relationship requires a new project or program to be established by the City of Greater Geraldton, a proposal should be developed containing all costs and resource commitments associated with the project or program. This will be subject to the annual budget allocation processes of the City of Greater Geraldton and will be treated as a new proposal to be assessed by Council on its merit alongside any other new projects competing for funding through the annual budget process.</p> <p>8. Management processes associated with the development and operation of International Relationships</p> <p>4.1. Australia's Foreign Relations (State and Territory Arrangements) Act 2020.</p> <p>According to the Australia's Foreign Relations (State and Territory Arrangements) Act 2020 a Local Government should:</p> <ul style="list-style-type: none"> • Notify the Minister of foreign Affairs of a proposal to enter any non-core* foreign arrangement. • Notify the Minister of Foreign Affairs within 14 days after entering a non-core foreign arrangement. <p>* A non-core foreign arrangement are any arrangements that do not involve both State/Territory government and a foreign national government. This includes arrangements between local governments and any foreign government entities.</p> <p>4.2. Management of International Relationships</p> <p>After a new relationship has been approved by Council, and the Minister of Foreign Affairs notified, all activities associated with programs (such as visits overseas, hosting visits and coordinating local groups seeking to engage with Sister Cities or Strategic Partner Cities) should be coordinated by the Economic Development Officer responsible for international relationships, in consultation as necessary with the Mayor and CEO, to ensure that all activities meet the objectives of this policy.</p> <p>4.3. Relationship Plan</p> <p>Every international relationship under consideration should have a relationship plan outlining:</p> <ul style="list-style-type: none"> • The key objectives of the relationship.
