At 1 July 2014, the Geraldton Sailors & Soldiers Memorial Investment had a balance of \$23,865.28.

CHEQUE ACCOUNT ACTIVITIES:

At 1 July 2014, the Memorial Trust's Cheque Account had a balance of \$36.13.

BACKGROUND:

The State Heritage Office has recently undertaken a draft assessment of Birdwood House to establish its cultural heritage significance.

The draft assessment was presented to the Heritage Council Register's Committee at its June 2015 meeting where the Committee resolved that the place is of cultural heritage significance. Therefore the State Heritage Office is seeking comments on the proposed entry of Birdwood House, Geraldton in the State Register of Heritage Places.

ADMINISTRATIVE COMMENT:

The draft assessment presented to the Heritage Council Register's Committee was based on the 2008 Conservation Plan. The State Heritage Office is seeking comments based on whether or not the physical evidence accurately describes the place and whether or not we support the proposal to enter Birdwood House into the State Register.

If there have been any changes to Birdwood House since 2008, documentation (including photographs if available) detailing works undertaken and / or the declining condition of certain elements needs to be provided to be incorporated into the assessment documentation.

RECOMMENDATION:

Geraldton City RSL provide documentation to State Heritage Office detailing changes to Birdwood House since 2008 as discussed at the Geraldton Sailors, Soldiers & Airmen Memorial Trust meeting on 25 September 2015.

Geraldton Soldiers, Sailors and Airmen Memorial Trust had been successful in securing Recurrent Community Grant funding of \$2,000 per annum from the City of Greater Geraldton. 2014 / 15 was the final year for this funding, and we have been advised that the Recurrent Community Grants will no longer be offered into the future.
