Owners and Occupiers of lands, other than within a townsite, shall clear of all flammable material firebreaks of at least three (3) metres width as close as practicably possible inside and along the whole of the external boundary of their property or properties.

TOWNSITE LAND

Owners and Occupiers within a townsite shall:

- (a) Clear of all flammable material the whole of the area where;
 - (i) The area of the land is 2023 square metres or less or,
 - (ii) The land is used for storage of flammable liquids, or
 - (iii) There is a hotel situated thereon.
- (b) If the area of land exceeds 2023 square metres (half an acre):

- (i) Clear of all flammable material firebreaks at least two (2) metres wide immediately inside all external boundaries of the land, or
- (ii) Have the grass mown to a height of not more than 50mm over the whole of the land, except where the land is used for the storage of flammable liquids.

3. HOMESTEADS, BUILDING, HAYSTACKS, STACKS OF FODDER, BULK FUEL, DRUMS AND LIQUID PETROLEUM

Owners and Occupiers of land shall:

During the period from 1st day of October, 2008 to the 31st day of March 2009, inclusive, have firebreaks at least three (3) metres wide in such positions as are necessary to completely surround the perimeter of any homestead, building, fuel installation (including drums), haystack (where such a haystack is situated within 200 metres of any homestead, building, fuel installation) or group of such structures or installations.

harvesting

A fully operational mobile fire-fighting unit complete with a container with at least 400 litres minimum capacity of water is to be readily available to any paddock being harvested. A fully operational plough, tillage or cultivator equipment is to be readily available, and in close proximity, to any paddock being harvested. The responsibility to supply these units being that of the landholder.

If for any reason it is considered impractical to comply with any provision of this notice, a written application for a variation may be made to the Shire Council and must reach the Chief Executive Officer by the 30th day of September 2008. Any such application must bear the signature of the Fire Control Officer of the area signifying his agreement to the variation.

If permission for variation is not granted, the terms of this notice must be complied with, or as the Council directs.

6. REGISTRATION

It is in the interest of all residents to be registered members of the Bush Fire Brigade covering the area in which they own land. Membership of a Brigade is the safest way to ensure cover under the Shire's Fire Insurance Policy which covers personal injury and damage to equipment resulting from fighting bush fires under the direction of a Fire Control Officer.

FLAMMABLE MATERIAL is defined for the purpose of this order to include bush (as defined in the Bush Fire Act), boxes, cartons, paper and like flammable materials, rubbish and also combustible matter, but does not include green standing trees or growing bushes or plants in gardens or lawns.

The penalty for failing to comply with this notice is a fine of \$250 by infringement notice or not more than \$5000 if prosecuted, and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

SUMMARY:

Report presents an item from the minutes of the Mullewa Community

Trust for a review of its criteria and guidelines.

BACKGROUND:

Reference is made to the Mullewa Community Trust Criteria and Guidelines which provides intending applicants with relevant details and operations of the Trust and is used by the trust committee to allocate the funds. The Committee of the Mullewa Community Trust have recommended that the MCT criteria and guidelines be reviewed to allow more flexibility regarding Council owned facilities and or services and removing the current limit on funding for projects that may warrant funds in excess of the current limit. A copy of the latest version of the criteria and guidelines are attached at APPENDIX A.

COMMENT:

The Mullewa Community Trust was established by Council at the meeting held 20 October 2004. When establishing the committee, known as the Mullewa Community Trust (MCT) and due to the restrictions of the Local Government Act, the committee only has the power to make recommendations to Council in accordance with the criteria and guidelines, as laid down by Council from time to time.

At the meeting in October 2004 Council also resolved -

- That a minimum of one third of the annual contribution from Mount Gibson Mining Limited to the Structural Adjustment Fund shall be retained and invested, and
- That the Mullewa Community Trust shall ensure that the maximum amount to be provided to any group within a 12-month period is \$10,000.

At a subsequent meeting held 17 August 2005 Council resolved that -

Disbursement from Mullewa Community Trust annually shall be \$50,000.

Apart from the above, the guidelines were also amended at the 21 February 2007 meeting where Council resolved -

• THAT THE MULLEWA COMMUNITY TRUST GUIDELINES BE AMENDED BY:

THAT THE FIRST DOT POINT ITEM UNDER THE HEADING "WHAT WON'T BE FUNDED" CONTAINED IN THE MULLEWA COMMUNITY TRUST GRANT GUIDELINES, BE ALTERED TO READ: "PROJECTS WHICH ARE THE OPERATIONAL RESPONSIBILITY OF FEDERAL STATE OR LOCAL GOVERNMENT", AND

AN ADDITIONAL DOT POINT UNDER THE HEADING "OTHER CONSIDERATIONS" BE INCLUDED WHICH READS: INCORPORATED, NOT FOR PROFIT, VOLUNTEER, COMMUNITY GROUPS, SUCH AS ASSOCIATIONS AND AUXILIARIES, WHICH ARE ATTACHED TO GOVERNMENT AND PRIVATE ORGANISATIONS, ARE ELIGIBLE TO APPLY FOR FUNDING.

When establishing the Mullewa Community Trust the funds were to be disbursed annually in accordance with the following objectives

- Encourage cooperation and sharing between community groups to ensure that a wide range of people can benefit from community resources.
- Increase the range of, and access to, quality community, recreational, social and cultural activities, programs and services.
- Support community development initiatives and socially responsible community activities.
- Support groups that are working to assist economically or socially disadvantaged people.
- Encourage the community to promote its region through promotional activities.
- Encourage the development of excellence in recreational, sporting and cultural pursuits.

At the last meeting of the MCT it was considered that there needed to be some flexibility for the committee to make recommendations with the view to allow more flexibility regarding Council owned facilities and or services and removing the current limit on funding for projects that may warrant funds in excess of the current limit. An example was given at the meeting in relation to the Mullewa Swimming Pool where Council has allowed free entry in an effort to assist keeping young people occupied through the long hot summer. It was considered that Council could apply for the loss of the entry fees which are approximately \$8000 - \$10000.

It was also considered that the maximum limit of \$10000 restricts organisations like the Tennis or bowling club applying for additional funding to cover more of the playing surfaces which could save money. Obviously there are other examples and the committee would need to consider each application on its merits. Generally the current limits may stay in place but the wording of the guidelines and criteria should be amended to allow the committee discretion in making its recommendations.

The \$50000 annual limit appears to be arrived at using the minimum one third of the annual contribution from Mount Gibson being retained and invested. This was when the contribution was \$75000. It is now \$100000. When the Trust was first established the contribution was \$50000. Using the one third method the annual distribution should be \$66666.

- Deleting "or Local" in the first dot point under What Won't be Funded.
- Deleting dot point 10 that states "Projects that require ongoing funding or support other than the initial grant"
