# **REPEAL LOCAL LAW 2011**

Under the powers conferred by subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Greater Geraldton resolved on *[insert date 2011]* to make the following local law.

#### 1 Citation

This local law may be cited as the City of Greater Geraldton Repeal Local Law 2011.

## 2 Commencement

This local law will come into operation on the fourteenth day after the day on which it is published in the *Government Gazette*.
