This Child Safe Awareness policy is one of the ways the City demonstrates its commitment to being child safe and a zero-tolerance approach to child abuse.</p> <p>This policy aims to reduce the risk of harm and child sexual abuse in our communities by encouraging child safe environments to be created and maintained.
