# Draft Greater Geraldton 2031 Strategic Community Plan Community Feedback Report Background

The public comment period for the Draft Strategic Community Plan ran for three weeks from 29 April to 19 May 2021. Members of the community were given the option of providing feedback either online or in hard copy formats. Hard copies of the Draft Plan and feedback forms were available at the Geraldton Regional Library, QEII Seniors and Community Centre, Mullewa District Office and City Civic Centre.

The feedback period was promoted via a media release and consultation page on the City's website. Advertisements promoting the public comment period were placed in the Geraldton Guardian on 30 April, 7 May and 14 May 2021, in the Mid West Times on 5 May and 12 May 2021 and in the May edition of the Mullewa Mail community newsletter. Emails inviting members of the community to provide feedback were sent to various City databases including schools, community groups, seniors, sports and recreations clubs and organisations, etc... A social media campaign ran on Facebook with posts promoting the feedback period on 29 April, 10 May, 14 May and 17 May 2021.


#### Community Feedback

During the public comment period, 38 community members provided their feedback on the Draft Plan. Overall, the majority of respondents agreed the Draft Plan reflected the views and aspirations of the community. Specific feedback on aspects of the Draft Plan follow.
