The investment is expected to achieve a predetermined market average rate of return that takes into account the Council's risk tolerance. Any additional return target set by Council will also consider the risk limitation and prudent investment principles. Prudent Person Standard The investment will be managed with the care, diligence and skill that a prudent person would exercise. Officers are able to manage the investment portfolios in accordance with the spirit of this Investment Policy, and not for speculative purposes. 			

5.3. Ethics and Conflicts of Interest

Officers shall refrain from personal activities that would conflict with the proper execution and management of Council's investment portfolio. This policy requires officers to disclose any conflict of interest to the CEO.

5.4. Approved Investments

- Derivative based instruments
- Principal only investments or securities that provide potentially nil or negative cash flow
- Stand-alone securities issued that have underlying futures, options, forward contracts and swaps of any kind.

This policy also prohibits the use of leveraging (borrowing to invest) of an investment.

5.6. Risk Management Guidelines

Investments obtained are to comply with two key criteria relating to:

- Portfolio Credit Framework limit overall credit exposure of the portfolio.
- Counterparties Credit Framework limit exposure to individual counterparties / institutions.

5.7. Overall Portfolio Limits

5.3. Ethics and Conflicts of Interest

Officers shall refrain from personal activities that would conflict with the proper execution and management of Council's investment portfolio. This policy requires officers to disclose any conflict of interest to the CEO.

5.4. Approved Investments

Without approval from Council, investments are limited to:

- Bonds that are guaranteed by the State or Commonwealth Government with a maturity of 3 years or less
- Interest bearing deposits with an ADI or WATC with a maturity of 3 vears or less
- Bank accepted / endorsed bank bills

5.5. Prohibited Investments

Unless explicitly authorised by Council, this investment policy prohibits any investments in:

- Derivative based instruments
- Principal only investments or securities that provide potentially nil or negative cash flow
- Stand-alone securities issued that have underlying futures, options, forward contracts and swaps of any kind.
- Commercial Paper
- Bank negotiable Certificates of Deposit

This policy also prohibits the use of leveraging (borrowing to invest) of an investment however, nothing in the policy shall prohibit the short-term investment of loan proceeds where the loan is raised for non-investment purposes and there is a delay prior to the spending occurring.

5.6. Risk Management Guidelines

Investments obtained are to be considered in light of the following key criteria:

- Preservation of Capital the requirement for preventing losses in an investment portfolio's total value.
- Credit Risk The risk that a party or guarantor to a transaction will fail to fulfil its obligations; risk of loss due to the failure of an institution/entity with which an investment is held to pay the interest and/or repay the principal of an investment.
- Diversification the requirement to place investments in a broad range of products so as not to be over exposed to a particular sector of the investment market.
- Liquidity Risk the risk an investor runs out of cash, is unable to redeem investments at a fair price within a timely period, and thereby incurs additional costs or is unable to execute its spending plans.
- Market Risk the risk that fair value or future cash flows will fluctuate due to changes in market prices, or benchmark returns will unexpectedly overtake the investment's return.
- Maturity Risk the risk relating to the length of term to maturity of the

Removed the following and moved to prohibited investments as the City does not deal with these investment instruments:

- Commercial Paper
- Bank negotiable Certificates of Deposits

Approved Investments (expansion to definitions of investments)

- Bonds that are guaranteed by the State or Commonwealth Government with a maturity of 3 years or less
- Interest bearing deposits with an ADI or WATC with a maturity of 3 years or less

This change expands/clarifies on approved investments we can invest with. The current policy only states Federal or State Bonds, but the proposal goes further to include Bonds guaranteed by State and Federal Governments. It also proposes to increase the tenure of investments to 3 years in line with what is now allowed under the Local Government Financial Regulations.

Nothing in the policy shall prohibit the short-term investment of loan proceeds where the loan is raised for non-investment purposes and there is a delay prior to the spending occurring.

The current policy prohibits borrowing funds for the sole purpose of investing. This proposal gives clarification on investing funds that we receive by way of loans for capital projects. It proposes that we should be able to invest the funds if there is a delay in the project the funds are earmarked for. This change clarifies what we already do.

If any of the City of Greater Geraldton investments are downgraded such that they no longer fall within the investment policy, they will be divested as soon as practicable.

6. Investment Advisor

Should the City of Greater Geraldton wish to employ the services of an investment advisor it must be licensed by the Australian Securities and Investment Commission. The advisor must be an independent person who has no actual or potential conflict of interest in relation to investment products being recommended; and is free to choose the most appropriate product within the terms and conditions of the investment policy

For the purpose of this Policy, "Major Banks" are currently defined as the ADI deposits issued by the major Australian banking groups:

- Australia and New Zealand Banking Group Limited (ANZ);
- Commonwealth Bank of Australia (CBA);
- National Australia Bank Limited (NAB);
- Westpac Banking Corporation (WBC)

Including, ADI subsidiaries (such as BankWest) whether or not explicitly guaranteed, and brands (such as St George).

Council may ratify an alternative definition from time to time. Standard & Poor's ratings attributed to each individual institution will be used to determine maximum holdings. In the event of disagreement between agencies as to the rating band ("split ratings") Council shall use the higher in assessing compliance with portfolio Policy limits, but for conservatism shall apply the lower in assessing new purchases.

Recognising that lower the rating the higher the risk, adding the additional category – "BBB Category & Unrated ADIs) is not exposing Council to any significantly elevated risk but it does enable the City to extend its investment range to achieve greater returns.

Similar related changes as per section 5.7 – recognises investment in lower rated ADIs to be at level that provides less exposure to Council.

Investments not explicitly rated, but issued by an ADI, will be grouped according to the highest rating of the parent ADI.
