<4>	<p><u>ITEMS FOR DISCUSSION</u></p> <p>1) <u>Graffiti and Vandalism</u></p> <p>NB reported there have been minimal graffiti reports, McDonald carpark machines graffitied with red texta, minimal amount on water tanks. NB said it's a case of not reported, small cases, NB spoke about patrols done, when graffiti is found it is photographed and actioned whether it's on City of Greater Geraldton or private land. Goodbye Graffiti.com needs more promotional work.</p> <p>DB asked about the water tanks, there is no graffiti on the tanks</p> <p>KW reported due to the anti-graffiti cover over the urban art nothing has been defaced, it's been very successful. KW suggests we take a look at the old shed building with its new nautical theme work due to commence this week.</p> <p>BW reported there have been very few reports of graffiti in Mullewa; a vacant City home waiting for demolition has been targeted.</p> <p>Mullewa Police told the meeting there has been no graffiti from the Police perspective.</p> <p>NB asked committee if "Free Jake" should be removed from Maitland Park water tank now that he has been released from prison which is great news. The committee agreed that it should be removed. NB said grey out the "Free Jake" off the water tank.</p> <p>KW said the water tank is used for artwork to promote community events in the park.</p> <p>2) <u>Crime Prevention through Environmental Design</u></p> <p>KS spoke about the CCTV project with over ½ million dollars of Federal Government funding, the projects have gone very well. The HMAS Memorial site has now been completed with the Foreshore and Parking Station 5 opposite Woolworths which should be completed by the end of the year. KS said a few cameras @ Mullewa, 1 across the road from the Civic Centre, another outside the old Telstar building with another across the road from the Mullewa Hotel. KS said this brings City of Greater Geraldton to over 100 CCTV cameras which will eventually be connected to the Police Station; there may be a few that are inside of</p>	ALL

	<p>buildings that may not be connected to the Police.</p> <p>NB mentioned the cameras to be added to the Wonthella Skate Park and the Aquarena. KS said part of the reason is due to the action at the pool with ongoing issues with people jumping fences etc., the cameras will tighten up security in this area, there have been cases of people turning on fire hydrants and flooding car parks and throwing equipment into the pool, it will address ongoing issues.</p> <p>Sports Meeting and local Police, NB & JH will attend with Ryan Thompson</p> <p>NB & RT were involved in audits done on sporting facilities to reduce crime and vandalism; this has the full support from City of Greater Geraldton and Police.</p> <p>DB said this has fits and spurts and asked if it was alcohol related?</p> <p>MO spoke of La Fiamma, said it was core groups that hit those locations, they do time inside then when they are released it starts all over again. GW said the Police usually know who these offenders are. GW said under reporting found out during the recent audit.</p> <p>NB spoke about incentives to rectify, she said she does not like social media and one story but it is not as bad as it is perceived to be.</p> <p>KS spoke of the Liquor Accord meeting he attended recently. The meeting prior to this was in 2012, good news that the meetings have commenced again. Crime Prevention through Design is looking at relocating taxi ranks from outside the Vibe and the lighting in the area, KS said he may get more funding for this. KS mentioned to move the taxi rank may cause more issues in Marine terrace, will keep meeting with the accord and keep Crime Prevention Meeting and the Accord up to date with information.</p> <p>3) <u>Property Crime (Theft & Burglary)</u></p> <p>MO said he has lived in Geraldton for 3 years now, he said they are up against Police perspectives. He is looking for new ways to get message out to the public to lock up cars and homes, he spoke of the groups wandering the streets looking for unlocked cars and homes, sometimes they may not intend to steal from cars but opportunity knocks when the vehicle is unlocked and the effects are in clear view. MO said he cannot get the message out and have an impact to see change. There have been burglaries where windows have been smashed, very minimal in the overall scheme of things.</p> <p>KW mentioned that a colleague had recently been broken into through entry on the second story; she was surprised by the agility of them.</p> <p>MO mentioned a recent vehicle stolen when the garage door was accidentally left open and the keys were left in the ignition. It is a larger problem during the school holidays with young people wandering the streets where they tell their parents they are staying at a friend's place; instead they wander the streets in groups and stealing from vehicles.</p> <p>PC spoke of issues experienced at the Dome, reported that kids have been going in causing a ruckus.</p> <p>KS attended meeting in December 14 - business owners were anxious with perceived increase of people running through shops and restaurants, the Dome issue was floated, more concern for Midwest Business Community.</p> <p>KS & CEO attended a MWCCI retailers meeting recently, 3 stage workshop</p> <p>4) Business community 5) Government agencies; and 6) Local Government agencies Plan is good buy in from all stake sectors, talk of having stake in trying to prevent it.</p> <p>7) <u>Violence</u></p> <p>MO spoke of reactive and proactive policing developing, community</p>

	<p>engagement and getting out into the community. Run a program recently called "coffee with a cop", it was very poorly attended. PC spoke from a migrant perspective to stay away from Police and fly under the radar.</p> <p>JH said people don't report crime, the Police were really hoping the members of the public would come forward. This event was run on a Thursday evening from 4-6pm and after school crowd at Stirling's Centro. JH said Superintendent of Police was in attendance, the Police did get some valuable information, JH has since done some follow up.</p> <p>Police are to be scene, visible, deterrent, people may approach in street, be more accessible. Integrate slowly, building, through social media, tweeting and walking through the mall. Found families with kids were coming up to officers for a chat. Suggestion of local Policing cards with N°s for direct call to pass information through to Police from members of the public.</p> <p>JH said a push is needed on the use of 131444, trying to get the message out there.</p> <p>MO said Policing of the past does not work in 2015, the new style is based on Perth model, and it will be tailored to suit Geraldton.</p> <p>DB said statistics from past meetings – 40% from unsecured cars and homes and asked if Police had any current stats.</p> <p>MO said he cannot quote figures, most burglaries relate to unlocked windows and doors.</p> <p>DB spoke about complacency and not securing property & vehicles or reporting burglaries. Wandina and Seacrest have youth causing issues; members of the public are not calling Police when they are concerned.</p> <p>GW said if only incidents were reported, this could be the last piece of the jigsaw for the Police to apprehend offenders.</p> <p>DB said he cannot get past the complacency issues in his 3 years of involvement with this committee. Maybe request the Mayor to include on tag in paper, on Radio mama, ABC & Geraldton Guardian to try and get the message out there.</p> <p>JH said Councillor Hall goes on radio regularly through neighbourhood Watch</p> <p>DB suggests an approach to commercial stations. Facebook has been discussed before where small incidents are blown out of all proportion and not reported to correct authorities.</p> <p>MO said he had spoken to an ex colleague who had been checking out Facebook, he called MO, he asked the question, does he really want to come back to Geraldton? MO said Geraldton is not a crime hot bead, he would not be living here if it was.</p> <p>DB Police need to receive accurate information or they cannot act. He said there are some older people too fearful to walk out the front door. Incidents make the headlines that Geraldton is not safe? Need to get program out to the Geraldton Guardian and radio stations to alleviate these fears and let the public know that Geraldton is a safe place.</p> <p>KW suggested a message be left on vehicle or a business card to remind people about hand bags & valuables left in full view in vehicles, engage the community, JH suggested this not to be a very good idea as it would draw attention to the vehicle & valuables inside.</p> <p>MO said most of the crime happens at night at premises.</p> <p>SP said Everything Geraldton, hits and misses with this website, it is a platform to work from.</p> <p>MO says do not encourage to report via social media. It escalates name calling & racism slurs, some stories can attract up to 30-40 comments, try to govern, once it's out there & shared, its gone and out there unable to be retrieved.</p>

	<p><u>ACTION</u>: KS/MMcG to work together with Police to push the issues.</p> <p>KS- Need co-ordinated partnerships to make people aware: Monday Spirit Radio & ABC Wednesday Radio Mama</p> <p>MO said there is an element of the community who think they live away from Perth therefore they should not have to lock up their vehicles & properties. Times are rapidly changing where we do have to do this to protect our possessions.</p> <p>KW reported to committee that the youth bus was broken into recently, items taken TV, X Box and computer games. KW said she was disappointed in Youth group; the vehicle had been left un-locked.</p> <p>JH asked if KW had serial N^os, the Police may be able to find the stolen items.</p> <p>KR asked if Police and Neighbourhood still had ID engraving machine and UV pens to mark personal items with Drivers Licence No's, JH said the ID engraving machine is available, she said frequently hands out the UV pens and informs members of the public on how to use them.</p> <p>KR said maybe it's not complacency in not reporting crime, there appears to be more concern about follow up or repercussions if found out.</p> <p>JH said Crime Stoppers is anonymous, needs to be more awareness to make people aware their calls are anonymous or call 131444 for anything suspicious, the Police are in the car and out there.</p> <p>MM said she called the Police Station recently when there was a group of youths, maybe 12 of them, the question she was asked was "are you in fear?"</p> <p>She was not given the 131444 N^o to call. MM went out and spoke to the youth in the street, she said she could see them peering over her fence to see her German Shepherd looking back at them.</p> <p>JH advised the meeting that during normal office hours the phones at the station are manned. At night time there is no-one in the station to take the calls therefore all calls should be going through the 131444, the job is then allocated to an officer in Geraldton to attend. The question "Are you in fear?" helps Police prioritise jobs that come in.</p> <p>MO opened this segment by saying he is happy to take questions, its too large a topic to speak generally and cover it all.</p> <p>DB mentioned violence and feuding including Mullewa.</p> <p>MO said this is a sticky point, he has been away on 3 weeks leave therefore does not have a lot of information, it bubbles a while ago. Social media is a medium to voice and make threats, Police heard of an organised fight so they turned up at the location, it turned out to be nothing.</p> <p>MO touched on family violence co-ordinated with Department of Child Protection and Police. Police have a triage meeting every morning, supporting victims through meetings, ongoing social issues and the end result is that it is not getting any worse.</p> <p>PC said he son came home from John Willcock College recently and mentioned the Police had been at the school. JH said she is a member of the board so she is quite often there to sign papers etc. GW attends the school sometimes in the line of duty.</p> <p>PC said it was great to see the multi nova present around the school. She wondered about the temptation for people to speed along Verita Road, JH said a lot, recently a driver was sent a seizure notice all thanks to a civilian witness.</p> <p>DB said violence is not a big issue, there has been a huge social change</p> <p>8) <u>Youth</u> National Youth Week – A series of events are currently happening to celebrate National Youth Week below</p>

The Mural is facilitated by Shah Jackie and will involve young people in its design and implementation. The mural will feature a nautical theme and we thank the property owner Miles Obst for his encouragement and support of the project. We encourage everyone to pop on down for a look and say hello and watch the mural take shape.</p> <p>Wonthella Skate Park – Construction of the extension to the Skate park will commence on 20th April. BW said Jesse has had to return to Italy on family business, he had been a breath of fresh air in Mullewa</p> <p>BW said since the pool closed in Mullewa there has be better attendance at the youth centre, unfortunately there have been more fights; they are nipped in the bud pretty quickly with kids being suspended depending on the severity of the offence.</p> <p>BW advised the committee that the replacement of the youth centre has been approved by Council.</p> <p>YL spoke about attending a meeting of the Rangeway Utakarra Karloo Progress Association (RUKPA) at which a presentation was made in relation to the application for a liquor licence for a new store in Utakarra directly beside the current IGA Supermarket. 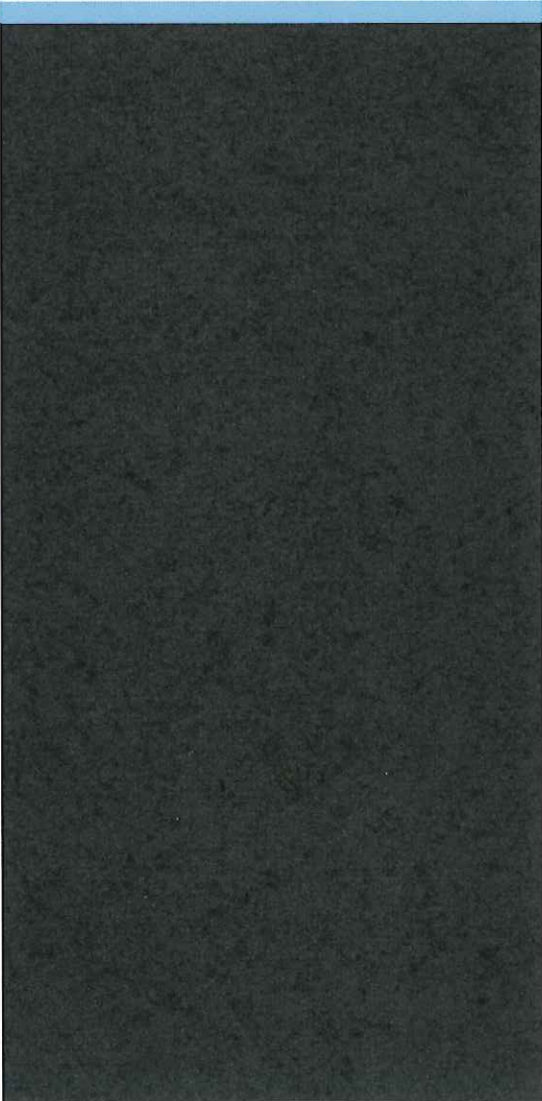
