INTRODUCTION

The City of Greater Geraldton has applied to the Minister of Commerce to extend trading hours for general retail shops in the City of Greater Geraldton, for a trial period of 12 months effective from 1 July 2017. The proposal would bring retail trading hours into line with Perth. Retailers would still choose for themselves when they open within the permitted hours of:

- 8.00 am 9.00 pm on Monday, Tuesday, Wednesday Thursday and Friday;
- 8.00 am 5.00 pm on Saturday;
- 11.00 am 5.00 pm on Sunday;
- 11.00 am 5.00 pm on public holidays;
- Closed on Christmas Day, Good Friday and ANZAC Day.

The City of Greater Geraldton needs to let the Minister know whether or not the community supports the proposed trial. A telephone survey of 400 community members across all suburbs was undertaken by research company Thinkfield, with statistically representative age and gender profiles. This report outlines the community's response.

SURVEY RESPONDENT DEMOGRAPHICS

The survey was conducted using a structured sample of the City of Greater Geraldton community (across all suburbs, with statistically representative age and gender profiles) that provided a statistically valid representative view of the community. The following charts show the distribution of age, gender and ward groups.

Figure 1: Survey Respondent Age Group




Figure 2: Survey Respondent Gender






Figure 3: Survey Respondent Ward



SURVEY RESULTS

The survey results show that 74% of the respondents support a trial period of 12 months to extend trading hours for general retail shops in the City of Greater Geraldton. The proposed extension of retail hours trial will bring the trading hours in line with Metropolitan Perth.

Figure 5: Respondent Response Breakdown by Gender




Figure 6: Respondent Response Breakdown by Age Group





Figure 7: Respondent Response Breakdown by Locality
