

Petition Guidelines

As Per City of Greater Geraldton Meeting Procedure Local Law 2011 s5.10 Petitions

- (1) A petition, in order to be effective, is to:
 - (a) be addressed to the Mayor or CEO;
 - (b) be made by at least 50 electors of the district;
 - (c) state the request on each page of the petition;
 - (d) contain the names, addresses and signatures of each elector making the request, and the date each elector signed;
 - (e) contain a summary of the reasons for the request; and
 - (f) state the name of the person upon whom, and an address at which, notice to the petitioners can be given.
- (2) Upon receiving a petition, the Local Government is to submit the petition to the relevant officer to be included in his or her deliberations and report on the matter that is the subject of the petition, subject to subclause (3).
