*\*Absolute majority required.*

***IMPORTANT to Note:*** Council members that attend committee meetings are all voting delegates. Without a quorum no decisions can be made at the meeting. Membership numbers do have a bearing on quorums of meetings.

***NOTE:*** As per *Local Government Act – section 5.10(4) – the Local Government is to appoint the Mayor to be a member of committee of which he has expressed a wish to be a member of.*
