There is no set fee for the service but clients are asked to make a contribution according to income, starting at \$5 for Centrelink beneficiaries. There is a waiver if there is an inability to contribute anything. Clients are not required to provide an income statement as their contribution is based on trust.

Centacare Family Services has been operating in Geraldton for 28 years. It is a not for profit, a Public Benevolent Institution and a Registered Charity. Counselling has been offered under the Family Law Act has been since 1989 At present Centacare has 2 offices in Geraldton and one each in the towns of Carnarvon, Exmouth, Yalgoo and Mt Magnet. Services operated from these offices include Family and Relationship Services, Family Law Services, Indigenous Parenting Service, Early Childhood Education and Family Support Centre, Victim Support Services, Indigenous Family Violence Support. Centacare employs 47 staff across the Midwest and Gascoyne regions which includes 4 psychologists, 2 conditionally registered psychologists, 6 social workers, a psychotherapist, two lawyers, a paralegal, two teachers and an accountant, includes 8 Aboriginal people who have family connections through the region, and all with local knowledge. Among these are 4 qualified Family Dispute Resolution Practitioners. Centacare has 4 remote offices- Exmouth, Carnarvon, Yalgoo and Mt Magnet, there is experience in management of remote services and supported both administratively and service provision. With the range of services under FARS and Family Law Services over many years, Centacare staff are well able to contribute and support expanded service provision. This range includes Family Counselling, Family Relationship Centre, Post Separation Cooperative Parenting.

As Centacare is in the middle of a refurbishment building programme on the premises at 3 Maltland St, it has been necessary to lease premises so that the counselling services can continue over the next 6 months. Half of the building has been closed off during the renovations. It was fortunate that we found the Francis St promises at the right time as it's a very suitable premise for the counselling services. There are five counsellors and an Administration Officer located at these temporary premises. The counselling services are open to the whole community without discrimination. In the past Financial year Centacare provided counselling to 1068 clients across 3586 contact sessions.
