#### **BACKGROUND:**

The City of Greater Geraldton previously offered the Geraldton Soldiers, Sailors and Airmen Memorial Trust a Service Agreement for the delivery of core services to the community. This Service Agreement expired 30 June 2021.

At the Ordinary Meeting of Council on 25 May 2021, Council resolved to:

APPROVE PROVISION in the 2021-22 to 2030-31 Long Term Financial Plan to conditionally allocate \$4,000 per annum for the life of plan to the Geraldton Sailors, Soldiers and Airmen Memorial Trust for the preservation of Birdwood House.

#### ADMINISTRATIVE COMMENT:

To ensure the continuation of services provided by the Geraldton Soldiers, Sailors and Airmen Memorial Trust, the City of Greater Geraldton offers a contribution of \$4,000 for 2021-22.

In line with the Council resolution above, \$4,000 is provisionally allocated in the 2021-22 to 2030-31 Long Term Financial Plan each year up to and including 2030-31. The allocation will be confirmed (or otherwise) during the budget deliberations in the June prior to each financial year.

Birdwood House Lease Agreement

#### **BACKGROUND:**

The purpose of this report is to seek a decision from the Trustees on the extension of the lease of the land and premises known as Birdwood House between the Trustees of the Geraldton Sailors and Soldiers' Memorial Institute and The Returned and Services League, Geraldton City Sub-Branch (the RSL).

#### **ADMINISTRATIVE COMMENT:**

The existing lease commenced 1 July 2015 and expired 30 June 2020. The existing lease includes 2 options to renew the lease of five years each, the first of which has not been formally accepted.

The RSL have continued to utilise the land and premises since 1 July 2020 in line with the intention of the lease option to renew the agreement. Formally extending the lease will confirm the terms of the lease agreement.

I am moving this motion to formalise the lease extension for the first of the five year options to 30 June 2025 under the same terms of the existing lease agreement.

**TENANCY AGREEMENT** 

#### **BETWEEN**

The Trustees of the Geraldton Sailors and Soldiers' Memorial Institute ("the Trustees")

#### AND

The Returned and Services League, Geraldton City Sub-Branch (the RSL)

#### WHEREAS

The Trustees are registered as the proprietors of all the land and premises known as BIRDWOOD HOUSE being the whole of the land comprised in Certificate of Title Volume 1035 Folio 737 together with the buildings, chattels and improvement erected and standing thereon ("the Premises") by virtue of the Geraldton Sailors and Soldiers' Memorial Institute Act 1929 as amended ("the Act") as attached in "Annexure A".

AND WHEREAS the Trustees with the approval of the Governor are authorised under Section 6(c) of the Act to lease the said land for the term with or without the right to renewal or option to purchase and subject to such covenants conditions and agreements as they may think fit.

#### AND IT IS HEREBY AGREED between the parties as follows:-

- The Trustees agree to demise the Premises to the RSL for a period of five (5) years, with the option to renew the agreement for an further five (5) years and then an additional five (5) years, commencing 1 July 2015 and ceasing 30 June 2020.
- 2. The RSL will pay to the Trustees the sum of one dollar (\$1.00) per annum as rental and will pay the rental on demand.
- 3. The RSL will refuse admission to the building or premises to any person or persons and if any such person or persons have gained

admission will see that they are removed from the premises by normal process of the law.

- 4. The RSL will have the right to use all furniture and chattels provided by the Trustees for their use and will keep all such furniture and chattels in good order and condition, fair wear and tear expected.
- 5. The RSL will provide the Trustees with a complete inventory of all contents of the building and appurtenances thereto.
- 6. The RSL will pay all charges for electric light, power, gas and water.
- 7. The Trustees may at all reasonable times enter with or without work persons and inspect the premises and shall have the right at all reasonable times to hold meeting on the premises.
- 8. The RSL will pay all outgoings in respect of the buildings and land including insurance which shall be affected with an insurance company approved by the Trustees and for an adequate amount to cover the replacement cost of the buildings and contents.
- 9. If the RSL make default in the performance of any of the conditions hereof and if such default shall continue for a period of thirty (30) days from the posting of a notice in writing specifying such default addressed to the RSL President. The Trustees may by further notice in writing of intention to cancel this agreement and if such default has not been remedied within the time allowed by the second notice may cancel this agreement.
- 10. The RSL retains the right to sublet the premises and land and to enter into lease agreements with organisations or persons as approved by the RSL. All revenue received to remain the revenue of the RSL.
- 11. The RSL while conforming to the covenants and conditions hereof shall have quiet use and enjoyment of the land and buildings hereby demised.
