These training times are determined by the League. | No junior teams affiliated with the clubs including colts, however the clubs all host the colts teams alternatively each week after their game on a Friday night. This gives them the opportunity to show the colts the benefits of their club and entice them to play for that particular club. | Training on only half a ground (2 teams train at the same time twice per week). Club understands and accepts the situation. Have had few after hours altercations between the clubs after games. Clubs have a good relationship with the Police and manage problems. | Decreased costs to clubs, all clubs have access to large events and social activities that can bring the club's closer together. | Dubbo - Apex Oval | Dubbo City Council | James McKechnie - Recreation Manager | | 10+ | Apex Oval users groups (Dubbo CC has a representative) GMA/MOU in place that dictates how oval is to be used. | Yes - 250 lux on main oval and training lights on surrounding areas for training | Clubs submit bookings to use grounds and lights and pay user fees. | Yes. Only games played on weekends (strictly no training on the main ground) | Yes. Little cost to clubs. Union use an alternative ground away from Apex Oval. There are no club rooms at the reserve, which means each club can book a function room in the grandstand or go back to their offsite clubrooms / function area. Lights approx \$100 per hour to cover elect and replacement (approx 150% of usage) | Not always. Some of the league juniors train on the outsides reserves of Apex oval, while union juniors train at alternative venues. | Limiting the usage of the ground to games only (approx 15hrs per week) | High quality facility that has been able to attract elite level rugby league matches and A-league fixtures as well as regional and state level events.
