7 Reports to be Received

7.1 Coordinator Report

Highlights from report:

Successful youth initiatives: Late Night Basketball, Skate Today, A Day in the Laneway, Revolve Skate, and Battle of the Bands.

Positive outcomes with JK Foundation supporting youth reengagement post-justice system.

Collaboration with WAPOL on e-ridable theft prevention campaign.

Youth Precinct redevelopment underway; EOI open for Mitchell Street Community Garden.

ACTION: Updates sought from Sandra Carr's and Kirrilee Warr's Office in term of the results out of the meeting with Minister Whitby earlier in 2025.

The Presiding member requested an additional item on the agenda for "Round table updates"

7.3 Round Table Updates:

MWCCI provided an update on the implementation of banning notices in the retail sector, focusing on an educational approach. Initial engagement was with corporate businesses, and in collaboration with WAPOL, a guidance chart was developed to clarify the application of banning notices and their legal implications. Additionally, the "On Track to Thrive" program, targeting children aged 5 to 9, is scheduled for rollout in November.



B Hall noted the prompt graffiti removal and repairs to damage acts as a deterrent.

Ngala: Target 120 is delivered in partnership with Ngala, MEEDAC, and the Department of Communities, supporting at-risk youth aged 10 to 14 and their families. The program can assist up to 10 young people at a time, referred by partner organisations, with a focus on reengaging them in education.

MEEDAC: Conducts weekly Friday evening patrols using their bus to pick up young people, provide them with a meal and transport them to a safe location for the night.

DM Colliver thanked the WAPOL team for their handwork and effectiveness of their additional staff patrolling the CBD over the last few months.
