SUMMARY	Tenders were invited for the Stage 2 upgrade for the Mullewa Swimming Pool and at the close of the Tender period 3 Tenders were received.			
BACKGROUND:	In December 2001 Council received a report that was commissioned by the Department of Sport and Recreation into the condition of swimming pools in the Mid West. The report on the Mullewa Pool found many areas of the pool would need upgrading in the future. Since that report it has been noted that the plant room has deteriorated and would no longer comply with the Health standards of today. Council has acknowledged this and has moved to make the changes.			
	Tenders were accepted in February 2002 for the relining of the Swimming Pool Bowl and that work was carried out during 2002. However, no further work has been undertaken towards the other matters raised in the report. Council has moved to stage an upgrading program over the next couple of years to improve the facilities at the pool. The plant room is the first stage, with the second stage replacing the main inlet to the pool and the scum gutters with a "level deck". Stage 3 will include the entry, kiosk and change rooms.			
	Council recently replaced the plant room as the first stage of the upgrade program and is now in a position to decide on the commencement of the next stage.			
	Tenders were invited now due to the tender process and the supply time line for this work to happen during the swimming pool shut down period. It will also allow Council for any expenditure in the 2010/11 budget.			
COMMENT:	Tenders were invited for the Stage 2 Upgrade which consisted of following work –			
	 Re-piping of both Pools Removal of old gutter system & replacement with Wet Decks to both pools Complete surface blast of both pools Tiling of both pools Re-paving of concourse Enlarging balance and backwash tanks Associated pool equipment (starter blocks, handrails, false start poles)

- 9. Engineering & Certification

Tenders closed Friday, 9th April, 2010 and at the close of the tender, 3 Tenders were received from -

- Wetdeck Pools \$833,310 + GST
- AVP Commercial Pools \$975,250 + GST
- Aquatic Construction Services (ACS) \$827,325 + GST

References for all tenders have been checked and indications are that they are all capable of carrying out this work. As can be noted, the tender from Wetdeck and ACS reveal the prices are very close and the evaluation on a number of factors will need further discussion and assessment at the meeting to allow Council to decide on which tender to accept. A written evaluation will be tabled at the meeting to assist in this process. In the meantime there is some clarification of information to be requested from the tenders.

The budget estimate was \$770,000 and Council has received funding through the Community Sporting & Recreation Facilities Fund and have allocated Royalties for Regions funding to replace the plant room at the Mullewa swimming pool.

As the Shires of Carnamah and Coorow are withdrawing at that time and this requires a valuation of assets and liabilities, Cr Messina is proposing that Mullewa also be permitted to withdraw by agreement of the 7 seven member councils. Cr M Bagley advised that Mingenew may also request early withdrawal. Both Cr Messina and Cr Bagley advised that they had not yet discussed this with their councils. Cr Messina further advised that the remaining 4 Councils who are proposing amalgamation at 30th June 2011 could then negotiate with the CEO on details of	
	her contract. "	
COMMENT:	As can be noted from the above this matter will require consideration of Council.	
	As previously discussed by Council its future participation in the Mid	

West Regional Council resulted in giving the notice as required under the Establishment Agreement to withdraw. The notice required under the agreement can only take effect at July 1, 2011.

	The push from the Shire of Mullewa has been based around the impending amalgamations of the remaining five local governments (Morawa, Perenjori, Mingenew, Three Springs and City of Geraldton Greenough, Chapman Valley, Mullewa) by July 1, 2011. It is also felt that there is lingering concern remaining a participant for this period and therefore it is suggested that Council request consideration by the MWRC to allow Mullewa to withdraw at the same time as Coorow and Carnamah, July 1, 2010.			
	As can be noted in a previous report to the Mid West Regional Council a legal opinion (APPENDIX B) indicated that winding up of the Mid West Regional Council would require the agreement of all the participating Councils.
