G'day Hugh,

Thank you for your message.

Yes, I was in receipt of the National Trust (WA) Interpretation Strategy and the two recommendations you have shown. I have no executive role in any of these matters, only advisory which I am happy to continue in.

As I understand the situation, the Trust's recommendations are a matter for the CI authorities to implement so I am not clear as to what your official role is in the process. Nevertheless, I make the following comments:

1. I expect that the Gull Marker is a project that will need to be initiated by the Shire of Christmas Is. The design looked at by the Trust is a design by SmithSculptors and therefore its property.

2. The website that you show below is not the appropriate site for the information about the Unknown Serviceman as it is the private site of SmithSculptors, the designers and builders of the Memorial at Geraldton intended to provide information about the Memorial, how it started, who designed and built it and it's symbolism. I expect that the matter will have to be taken up by the Shire of CI with the City of Greater Geraldton (CGG) to include appropriate information in its own website, that of its Visitor Centre and of the HMAS *Sydney* Memorial. Similarly, any additional information at the memorial itself will need to be taken up with CGG which would ultimately involve SmithSculptors. To this purpose, I have Cc'd the Mayor of the CCG.

I am happy to provide guidance about appropriate content regarding information about the Unknown Serviceman, noting that it continues to be a matter of great sensitivity to the relatives of those killed in HMAS *Sydney*.

Dear Bob,

Since our meeting at the Perth office of the National Trust (WA) in April last year, the Trust has released the report on its Interpretation Strategy for Christmas Island in November. Page 45 of the report states that, "The removal of the 'Unknown Serviceman' purportedly from the HMAS Sydney from Christmas Island and the process of his reinterment has not been properly told at the memorial in Geraldton or on Island". [see attachment]

Accordingly, the Trust has made the following two recommendations,

- Emplacement of a single Gull Marker on Christmas Island which reflects the 'Dome of Souls' memorial to HMAS Sydney in Geraldton.
- Include information about the Unknown Serviceman and the connection to Christmas Island on the memorial website, <u>www.hmassydneymemorialgeraldton.com.au</u>, with consideration to on-site interpretation in Geraldton.

Do you agree with these proposals, and could you please advise if there is a plan and timeline for implementing changes to the memorial website and other on-site interpretation in Geraldton?

#### Good morning all,

I agree that the Unknown Serviceman and the related Christmas Island story should be told in a way that acknowledges this important part of history.

I'm sure that most on this address list know that my position on the body itself is quite clear – that it stays where it is, in the War Cemetery at Geraldton. It is not a matter for Christmas Is authorities to lobby on nor for bureaucrats Navy or the Office of War Graves to decide. It is a matter in which priority should be given to the wishes and feelings of the close relatives and descendants of all of those killed in HMAS *Sydney*, whom this man represents. Since finding the wreck of both *Sydney* and *Kormoran* in 2008 I have been in contact with some 1800 relatives at first and remain in frequent contact now with some 300 family groups. I have been to every Commemorative Service at Geraldton each November and met very many of those widows, sons, daughters, brothers, sisters at al. Moreover, since the notion that the body should be returned to CI was first raised I have canvassed the views of those family groups and almost to a person, they were shocked and distressed that any such action could ever be considered. They all believe that he belongs where he now lies. Any attempt to 'obtain' the body will fail on those grounds alone.

I suggest that now is the time to drop any intent to continue lobbying for the body to be re-exhumed and concentrate on more appropriate means of including Cl's part into the wider *Sydney* story. I am very happy to assist with finding those means.




